FOR A POINT OF BEGINNING, COMMENCE AT A 4" CONCRETE MONUMENT STAMPED L.B. 2372, MARKING THE SOUTHEAST CORNER OF THE NORTHEAST 1/4 OF THE SOUTHEAST 1/4 OF SECTION 34, TOWNSHIP 1 NORTH, RANGE 13 WEST, WASHINGTON COUNTY FLORIDA, THENCE RUN N 88'37'23" W ALONG THE SOUTH LINE OF SAID NORTHEAST 1/4 FOR 1326.94 FEET TO A 4" CONCRETE MONUMENT STAMPED L.B. 2372, MARKING THE SOUTHEAST CORNER OF SAID NORTHWEST 1/4 OF SAID SECTION 34; THENCE RUN N 88'37'55" W ALONG THE SOUTH LINE OF THE NORTHWEST 1/4 OF THE SOUTHEAST 1/4 OF SAID SECTION, 34 FOR 582.13 FEET TO THE EASTERLY EDGE OF MAINTENANCE OF NORTH BLUE SPRINGS ROAD (A COUNTY MAINTAINED GRADED ROAD WITH NO RECORDED RIGHT-OF-WAY); THENCE RUN THE FOLLOWING COURSES ALONG SAID EASTERLY EDGE OF MAINTENANCE N 07°42'05" W FOR 28.38 FEET; THENCE N 10°42'51" W FOR 73.54 FEET; THENCE DEPARTING SAID EASTERLY EDGE OF MAINTENANCE, RUN S 88'37'45" E FOR 1034.09 FEET TO A 1/2 INCH IRON ROD AND CAP STAMPED L.B. 7479; THENCE N 01'22'15" E FOR 420.00 FEET TO A 1/2 INCH IRON ROD AND CAP STAMPED L.B. 7479; THENCE S 88'37'45" E FOR 896.71 FEET TO A 1/2 INCH IRON ROD AND CAP STAMPED L.B. 7479, MARKING THE EAST LINE OF AFORESAID SECTION 34; THENCE RUN S 01°34'32" W ALONG SAID EAST SECTION LINE FOR 520.06 FEET TO THE POINT OF BEGINNING. SAID PARCEL CONTAINS 13.04 ACRES MORE OR LESS. SUBJECT TO A 100 FOOT EASEMENT AS RECORDED IN O.R.B. 460, PAGES 486 THROUGH 494 OF THE PUBLIC RECORDS OF WASHINGTON COUNTY, FLORIDA.
